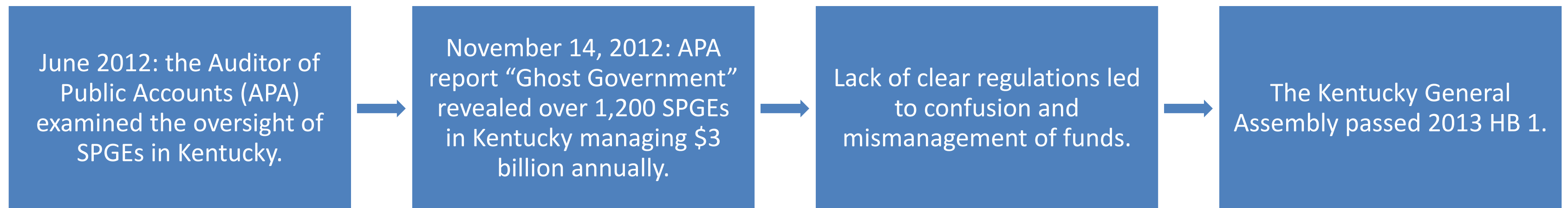

# Enhancing Oversight with KRS 65A and the SPGE Portal



HB 1 established Kentucky Revised Statute (KRS) 65A.



KRS 65A.020 requires all SPGEs to begin reporting to the Department for Local Government (DLG) on DLG's online reporting portal on or before July 1, 2014.



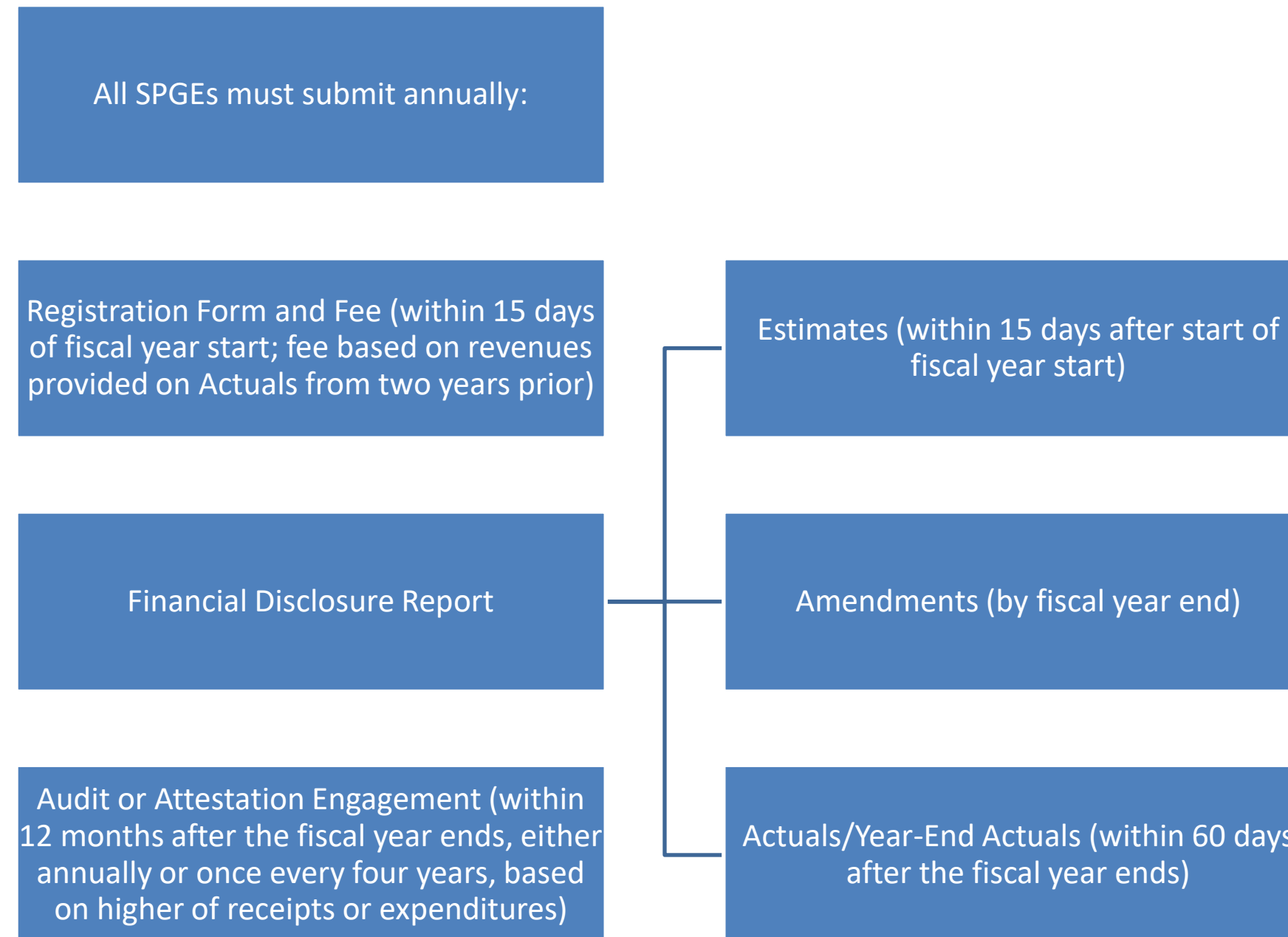
The portal serves as a unified location for the reporting of and access to SPGE administrative and financial information.



All SPGEs are required to annually submit information to DLG using the portal.

## SUBMISSION REQUIREMENTS

# Annual Reporting Requirements for SPGEs (KRS 65A.020-030)





# Registration Fee (KRS 65A.020)



Amount determined by the annual receipts from all sources, provided on the SPGE's Actuals from two years prior.

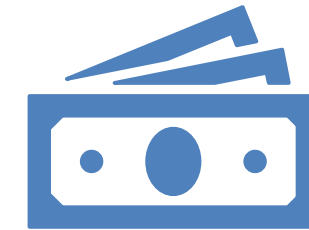


The fee amount will be:

\$25.00 if the annual receipts from all sources is less than \$100,000.00.

\$250.00 if the annual receipts from all sources is \$100,000.00 but less than \$500,000.00.

\$500.00 if the annual receipts from all sources is \$500,000.00 or more.



The fee amount can change each fiscal year.

# Audit and Attestation Engagement (KRS 65A.030)

Each fiscal year, the audit requirement is based on the higher of total annual receipts or expenditures from the current year's Actuals.

If the higher of annual receipts or expenditures is:

Less than \$100,000: attestation engagement once every 4 years.

Equal to or greater than \$100,000 but less than \$500,000: audit once every 4 years.

Equal to or greater than \$500,000: annual audit.

The audit requirement can change each fiscal year.

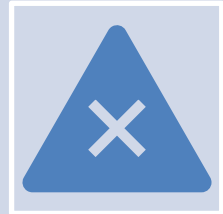

# NONCOMPLIANCE

# What Is Noncompliance? (KRS 65A.040)



SPGEs are noncompliant if they:

**Miss submission deadlines** (e.g., Registration, Financial Disclosure, Audit)

**Fail to pay registration or newspaper fees** (no submissions allowed until paid)

**Submit non-compliant information** (e.g., all zeros for Estimates and Actuals)



If documents are late, the SPGE portal shows noncompliance. DLG offers a 75-day compliance period, and penalties apply only after this period.

# Noncompliance Penalties (KRS 65A.040-050)



## State Funds Withheld

DLG will notify the Finance and Administration Cabinet, grant-issuing state agencies, and oversight agencies to withhold funds until the SPGE regains compliance.



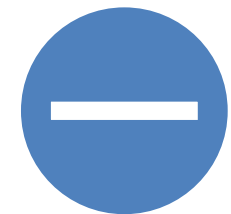
## Newspaper Publication of Noncompliance

SPGEs will be published in the largest circulating newspaper in each county served. The publication includes SPGE contact info, Board Members, and noncompliance issues. The SPGE covers publication fees.



## The Auditor of Public Accounts (APA) is informed of the SPGE's noncompliance

The APA is notified and may initiate an audit or special examination of the SPGE at the SPGE's expense.



## Possible Dissolution

DLG may dissolve an SPGE if it fails to file required information for two consecutive years.

The Public Portal is accessible to all for viewing SPGE submissions and compliance with KRS 65A; no account is needed.



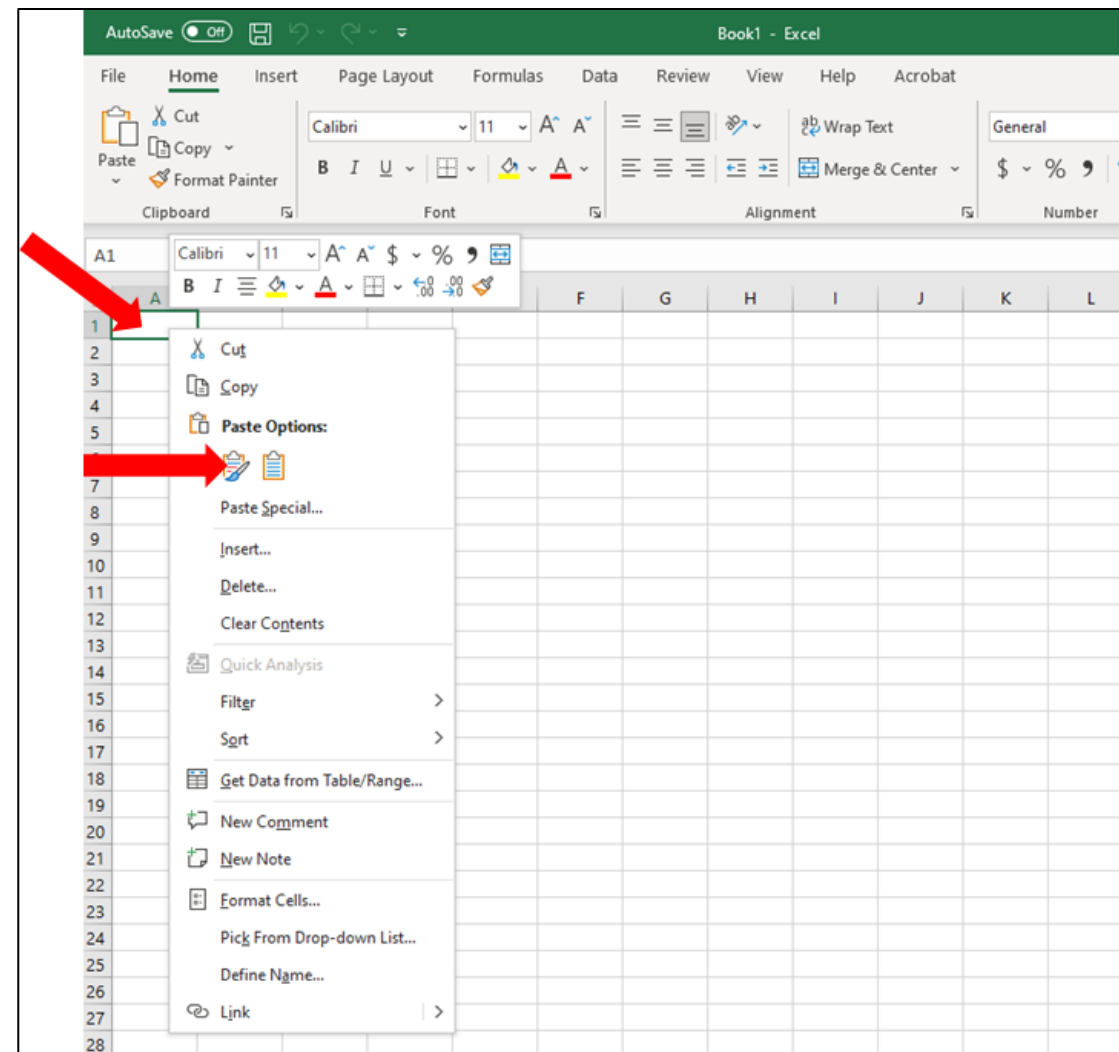
